ORDER

As per the Government order read above, Government have sanctioned an amount of Rs.2.3 crore for the work of supply and installation of unitised sub station, diesel generator and related works of the newly constructed COVID-19 Hospital at Thekkil Village of Kasaragod District by the TATA Projects Ltd. As per the letter read above, the District Collector, Kasaragod has informed that during the execution of the works, some additional works and items are seen needed for the satisfactory completion of the scheme, the Executive Engineer, PWD Electrical Division has submitted an additional estimate for Rs. 33,10,000/- for the same work and requested to give permission to utilize the above said amount from the amount already sanctioned for the work. It is also informed that additional estimate is within the original AS amount sanctioned by the Government, and this amount can be met from the amount of Rs.16 lakh kept for unforeseen items in the original TS estimate and tender savings of Rs.15.8 lakh in the work arranged.

Government have examined the matter in detail and are pleased to approve the revised estimate for the work of supply and installation of unitised sub station, diesel generator set, APFC Panel and other unforeseen items of the newly constructed COVID-19 Hospital at Thekkil Village of Kasaragod District by the TATA Projects Ltd subject to the condition that the

additional estimate is limited within the original sanctioned amount.
