ORDER

The Government, as per order read as paper 1 above, has constituted a two member Expert Committee with Shri M Madhavan Nambiar IAS (Retd.), former Civil Aviation Secretary & former Special Secretary Information Technology, Government of India as Chairman and Shri Rajeev Sadanandan IAS (Retd.), former Additional Chief Secretary (Health & Family Welfare Department), Government of Kerala as member, to examine the issues raised connected with engaging M/s Sprinklr Inc. by E& IT department for the activities connected with the containment of COVID-19 in the State.

Subsequently, as per order read as paper 2 above, Shri Rajeev Sadanandan was entrusted with the duty of advising Hon: Chief Minister on the matters related to COVID-19 epidemic. Hence the Chairman of the Committee proposed to replace him with Dr. Gulshan Rai, former Cyber Security Coordinator, Government of India as the former may not be able to spend much time for the affairs of the Expert Committee.

Government, having examined the matter in detail, are pleased to nominate Dr. Gulshan Rai, former Cyber Security Coordinator, Government of India in place of Shri Rajeev Sadnandan in the two member Committee constituted to examine the issues raised in the public domain connected with engaging M/s Sprinklr Inc., for the activities connected with the containment of COVID-19 in the State, by E& IT department


